Pardon/Reprieve/Commutation of Sentence hearing regarding Frank J. Atwood, ADC# 062887

Description: In May 1987, Frank J Atwood, ADC#062887, was convicted in Pima County Superior Court Case CR-15397 of First Degree Murder and was sentenced to death. The Arizona Supreme Court issued a Warrant of Execution on May 3, 2022. An execution date has been scheduled for June 8, 2022. At the Pardon/Reprieve/Commutation of Sentence hearing, the Board of Executive Clemency may receive information and may consider, discuss and vote on whether to recommend a Pardon/Commutation of Sentence and/or a Reprieve to the Governor.
