This hearing is open to the public but will have limited capacity. In person attendance will be on a first come basis, therefore, virtual attendance is strongly encouraged. Waiver of Clemency hearing regarding Aaron Gunches, ADCRR# 145371

Description: In 2007, Aaron Gunches, ADCRR# 145371, was convicted in Maricopa County Superior Court Case CR2003-038541-001 of First-Degree Murder, and was sentenced to death. The Arizona Supreme Court issued a Warrant of Execution on March 2, 2023. An execution date has been scheduled for April 6, 2023. **The Board of Executive Clemency has received a signed waiver of hearing from Aaron Gunches, ADCRR#145371. Pursuant to Board policy, the Board will confirm the waiver of hearing on the record at the above noticed date, time and location.**
