A copy of the agenda for the meetings will be available at the place of the hearings at least 24 hours in advance. The Board Chairperson may elect to enter into Executive Session, which will not be open to the public, to discuss any matter on this calendar pursuant to A.R.S §38-431.03(A)(3). Executive sessions will be held to allow the Board to discuss or consult with Board attorney for legal advice.
