Pursuant to A.R.S. §38-431.02, notice is hereby given to the Members of the Arizona Board of Executive Clemency and to the general public that the Board of Executive Clemency is meeting for the purpose of conducting a hearing on **July 16, 2014 at 8:30 a.m. at Arizona State Prison Complex Eyman-Rynning Unit, 4374 E Butte Avenue in Florence, Arizona 85132.** This hearing is open to the public. The Board may vote to go into Executive Session, which will not be open to the public, to discuss any matter on this agenda pursuant to A.R.S. § 38-431.03 (A) (3) (Discussion or consultation with Board attorney for legal advice). The Board may go into Executive Session pursuant to A.R.S. § 38-431.03 (A) (2) for discussion or consideration of records exempt by law from public inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law.

**Pardon/Commutation of Sentence/Reprieve hearing regarding
Joseph Rudolph Wood III, ADC# 86279**

***Description:* On July 12, 1991, Joseph Rudolph Wood III was convicted in Pima County Superior Court Case No. CR-28449 of First Degree Murder and was sentenced to death. The Arizona Supreme Court has issued a Warrant of Execution. The Arizona Department of Corrections has scheduled an execution date for July 23, 2014. At the Pardon/Commutation of Sentence/Reprieve hearing, the Board of Executive Clemency may receive information and may consider, discuss and vote on whether to recommend a Pardon, a Commutation of Sentence and/or a Reprieve to the Governor. All Board hearings are deemed public hearings in accordance with prevailing statutes. The Board may invite public comment.**
