
Phase I-Inabsentia

The meetings will begin at 8:30 a.m. and will be held at 1645 W. Jefferson St., Suite 101, Phoenix, Arizona. A copy of the agenda for the meetings will be available at the place of the hearings at least 24 hours in advance. The Board Chairperson may elect to enter into Executive Session for the purpose of receiving legal advice with the attorney for the Board as authorized by A.R.S. §38-431.03.A(3). Above is a list of the hearings and the days which they will occur. Inmates or persons appearing on this posting may be subject to removal from the hearing docket at the time or prior to the hearing date.
