The Board Chairman may elect to enter into Executive Session for the purpose of receiving legal advice with the attorney for the Board as authorized by A.R.S §38-431.03.A(3). Inmates or persons appearing on this posting may be subject to removal from the hearing docket at the time or prior to the hearing date. Please note hearings are not held on Friday.
